**Request for a Special Meeting Regarding the Orange County Power Authority**

---

Yesterday, on May 31, Orange County Power Authority's (OCPA) General Counsel Ryan Baron received a whistleblower complaint from CEO Brian Probolsky via counsel.<sup>1</sup> The letter is the latest in a series of troubling developments at OCPA.

The Orange County Power Authority has faced calls for transparency for more than a year. These calls have gone unheeded. For example, the following public records requests I made on March 24 remain outstanding:<sup>2</sup>

1. The number of small, medium, and large commercial customers OCPA [started serving] on April 1, 2022
2. The other account types OCPA is serving (e.g. residential customers) and the number of those customers OCPA is serving
3. The source of business data OCPA used to assemble its customers
4. OCPA's contingency plans in case more than 5% of residential customers and/or 10% of commercial customers opt out of its plans or opt "down" to the Basic Choice plan
5. Power Purchasing Agreements between Orange County Power Authority and other entities and the nature of those contracts, including the percentage that are medium-term (defined as 5 years or longer) v. long-term (defined as 10 years or longer)
6. Any and all reserve funds OCPA has created to address contingencies and other risk factors

Moreover, on April 20, the California Public Utilities Commission cited the Orange County Power Authority for failing to procure enough power to meet Resource Adequacy requirements and penalized OCPA \$1,962,845.<sup>3</sup>

It is clear that the Orange County Power Authority requires immediate public attention and urgent oversight. I write this memo to request that the Mayor and/or two of my colleagues join me to call for and schedule a special meeting of the City Council on or before June 14. The purpose of the special meeting is to discuss: 1) directing the City Manager to commence a City audit of the Orange County Power Authority,<sup>4</sup> and 2) assessing the City's exposure to liability.

For convenience, I have appended all cited materials.

Mr. Baron:

My firm has been retained to represent Brian Probolsky (“Client”) to advocate on behalf of whistleblower claims made against Huntington Beach City Councilmembers and Orange County Power Authority Board Members, Mike Posey and Dan Kalmick.

My client brings forward these allegations in an effort to protect the public’s interest. He has reasonable cause to believe that the actions disclosed in this letter are a violation of state or federal statute, or a violation of or noncompliance with a local, state, or federal rule or regulation. As a whistleblower, my client will aggressively pursue all legal rights and remedies under Labor Code Section 1102.5.

We request the below allegations be fully investigated and reviewed for any criminal or civil violations, and all findings and reports be provided to me at the contact information below.

**I. Mike Posey & Dan Kalmick Conspired to Defraud Government Agency:**

Based on multiple witness accounts spanning several weeks, Huntington Beach Councilmen Mike Posey and Dan Kalmick have allegedly conspired together to exert inappropriate influence over the Orange County Power Authority, to enrich themselves at the expense of the taxpayers.

At the meeting of the Huntington Beach City Council held on May 17, 2022, Councilmember Posey abruptly resigned his seat on the Orange County Power Authority, and subsequently, the City appointed Councilmember Kalmick in his place. Under the same council action, the council reinstated Posey as Huntington Beach’s alternate representative to the Orange County Power Authority. This conduct is in violation of the Brown Act as follows:

**II. Brown Act Violation: Failure to Properly Notice Council Action:**

Under the Brown Act, the public must receive proper notice of a government body's action. If an agenda item does not provide the public with an adequate description of an action the board intends to take or provides a description that is misleading, then the public has not received adequate notice of public items in which they may wish to participate.

In this case, on May 17, 2022, Council Agenda Item #9 was noticed as “22-428 *Re-appointment of Huntington Beach representative to the Orange County Power Authority (OCPA), and update of the 2022 Council Liaison List.*” Attached hereto as **Exhibit A** is a true and correct copy of the 05/17/2022 Council Agenda. By characterizing the agenda item as a **re-appointment**, rather than a new appointment, the City not only misled the public but also lacked the legal authority under the Brown Act to deviate from this action when roles were swapped by Posey and Kalmick, as no re-appointment of a former board member occurred. Ultimately, the public was deprived of ample time to anticipate Posey and Kalmick's plot to swap roles, which at a minimum, is a violation of the state's open meeting law. Attached hereto as **Exhibit B** is a true and correct copy of the City of Huntington Beach 2022 Council Liaison List, which clearly identifies Posey as the City of Huntington Beach's representative to the OCPA, with Kalmick as alternate (see page 5 of 6 of the attached exhibit, item #5), which confirms that this was not a re-appointment, but rather a new appointment, which changes the nature of the agenda item.

To date, the Orange County Power Authority has received no formal notice from the City of Huntington Beach authorizing a change in its delegated representative.

**III. Brown Act Violation: Serial Meeting and Another Failure to Properly Notice Council Action, and Criminal Liability for Violating Conflict of Interest Laws:**

**a. Brown Act Violation: Serial Meeting**

Information communicated to a quorum through series of contacts, individual phone calls (“daisy chain”), or a third person (“spoke and wheel”) to evade the public is a “meeting”. 63 Opps.Atty.Gen. 820 (1980); Stockton Newspapers v. Stockton Redevelop. Agency, 171 CA3rd 95 (1985); Common Cause v. Stirling, 147 CA3rd 518 (1893). Moreover, a serial meeting can occur even when the communication is for the purpose of developing a concurrence as to action to be taken on substantive matters that are or are likely to be on the board's agenda.

Here, Kalmick attempted to coordinate an official government action outside of a properly noticed meeting, when on or about May 2022, Kalmick called other Board Members asking for their support in next steps to remove existing agency management, including CEO Brian



Probolsky. This plot and scheme constituted a meeting, or at the very least a serial meeting, within the scope of the Brown Act. By calling Board Member Sonne, Board Member Jung, Board Member Khan, and others in an attempt to evade a public meeting via individual phones calls (“spoke and wheel”), an illegal violation of the state’s open meeting law occurred, and a serial meeting was conducted in violation of the Brown Act.

**b. Brown Act Violation: Another Failure to Properly Notice Council Action:**

Once again, under the Brown Act, the public must receive proper notice of a government body’s action.

Kalmick’s series of calls to board members in May 2022, constituted a serial meeting as described above for the purpose of developing a concurrence as to a substantive action to be taken within the board’s jurisdiction. Because the board failed to give adequate or any notice to the public of a government body’s deliberation or discussion on the matter, Kalmick’s actions once again violated the Brown Act and open meeting laws.

**c. Criminal Violation of Conflict-of-Interest Laws:**

Additionally, as further support, on or about May 25, 2022, Huntington Beach City Councilman Mike Posey attended an event with several other people, including but not limited to Orange County Supervisor Don Wagner (an OCPA Board Member not part of the conspiracy), a former vendor of the OCPA, and Paul Simonds, an employee of Curt Pringle & Associates. When asked why he had swapped seats with Kalmick on the OCPA Board, he replied that since he was termed out of office, he had an interest in working for OCPA as Chief Business Officer. Currently, the Orange County Power Authority has no position of "Chief Business Officer" nor any plans to create such a position.

Posey and Kalmick’s attempt to subvert the state’s open meeting laws is part of an attempt to not only to self-deal in violation of their fiduciary duties, but also to create an oral employment contract for a non-existent position as “Chief Business Officer.” As OCPA board members, both Kalmick and Posey owe a fiduciary duty of loyalty and care, and to act in good faith and fair dealing. As has been relayed to many people at various events over the past several weeks, several witness accounts establish that Posey and Kalmick conspired to create a common plan and scheme to insert Kalmick onto OCPA’s Board, fire the CEO, Brian Probolsky, and hire Posey to serve as "Chief Business Officer" – a position neither authorized nor created by the other Board members.

Additionally, due to the conduct described above, Posey and Kalmick have both violated Government Code Section 1090, as they are attempting to steer a job to Board Member Posey by trading out Board seats in exchange for a paid position with OCPA.

Government Code section 1090 prohibits an officer or employee from entering into or participating in making contracts in which they have a financial interest:

*(a) Members of the Legislature, state, county, district, judicial district, and city officers or employees shall not be financially interested in any contract made by them in their official capacity, or by any body or board of which they are members. Nor shall state, county, district, judicial district, and city officers or employees be purchasers at any sale or vendors at any purchase made by them in their official capacity. (Gov. Code, § 1090, subd. (a).)*

On or about May 26, 2022, in furtherance of the conspiracy, and against the policies and procedures of the OCPA and California law, Kalmick began calling OCPA Board Members, requesting their attendance at a June 7, 2022, Special Meeting to "clean house" at OCPA, where they plan on executing their illegal scheme.

In addition to seeking to enrich himself through the creation of a new "Chief Business Officer" position, Posey has exerted undue influence over the Orange County Power Authority and abused his position as a Board Member by making several unsuccessful requests that OCPA hire two of his political associates. My Client repeatedly refused these inappropriate requests and has reason to believe that Posey's actions pushing for his removal are retribution.

On or about May 29, 2022, Board Member Sonne finally outlined the conspiracy to CFO Tiffany Law. In a phone call to Law, Sonne outlined that "there will be a special meeting, there are votes to fire Brian, bring in management from Marin, and hire new Executives." Sonne also told Law "not to believe anyone who says anything differently." The reasons cited by Sonne to Law included "lack of experience and transparency." CFO Law reported this conversation to CEO Probolsky immediately because she believed that it was both inappropriate and untrue. CFO Law has more experience in CCE's than any of the Board Members and can and will speak to CEO Probolsky's professionalism and leadership. As for transparency with Sonne, the fact that she has been part of a conspiracy to remove Probolsky speaks for itself as to why she would feel that she wasn't getting all of the available information.

My client, OCPA CEO, Brian Probolsky, is entitled to whistleblower protections under state law. He is an experienced government executive with more than a decade in government management, and fourteen years working in public utilities. Under the leadership of Probolsky,

OCPA has enjoyed financial and operational success like other California power agencies and has achieved the single highest proportion of 100% renewable customers in the State. The “cover” of Brian’s “lack of experience” is nothing more than a cover story for Posey, Kalmick, and Sonner to attempt to carry out their conspiracy to take control of the organization and to install their people.

Mr. Probolsky is acting in the capacity of whistle blower and is entitled to the protections afforded to whistleblowers under the law. His sole motivation has been and continues to be the success of the Agency. He is fulfilling his duties as head of a public agency, accountable to the taxpayers, to protect the public and prevent Directors Posey and Kalmick from executing their conspiracy to defraud the public.

We request the below allegations be fully investigated and reviewed for any criminal or civil violations, and all findings and reports be provided to me at the contact information below.

## ORANGE COUNTY POWER AUTHORITY JOINT POWERS AGREEMENT

This Joint Powers Agreement (“**Agreement**”), effective as of the date specified in Section 1.2, below, which is November 20, 2020 (“**Effective Date**”) is made and entered into pursuant to the Joint Exercise of Powers Act (California Government Code § 6500 *et seq.*) relating to the joint exercise of powers among the parties set forth in Exhibit A. All parties that execute this Agreement prior to December 31, 2020 shall be designated individually as “**Founding Party**” and collectively as “**Founding Parties**”. All cities, counties, or other public agencies added as parties to this agreement after December 31, 2020 shall be designated individually as “**Additional Party**” and collectively “**Additional Parties**”. The term “**Party**” refers individually to any Founding Party or Additional Party, and the term “**Parties**” refers collectively to the Founding Parties and the Additional Parties.

### RECITALS

A. In 2002, Assembly Bill 117 (Stat. 2002, Ch. 838, codified at Public Utilities Code Sections 218.3, 366, 394, 394.25, 331.1 366.2, and 381.1) was signed into law allowing customers to aggregate their electrical loads as members of their local community with public agencies designated as community choice aggregators, and allowing such public agencies to aggregate the electrical load of interested consumers within their jurisdictional boundaries and purchase electricity on behalf of those consumers.

B. In 2006, Assembly Bill 32 (Stat. 2006, Ch. 488, codified at Health and Safety Code Sections 38500 *et seq.*), known as the Global Warming Solutions Act, was signed into law, mandating a reduction in greenhouse gas emissions to 1990 levels by 2020.

C. In 2015, Senate Bill 350 (Stat. 2015, Ch. 547, codified at Health and Safety Code Section 44258.5; Labor Code Section 1720; Public Resources Code Sections 25302.2, 25310, 25327 and 25943; and Public Utilities Code Sections 237.5, 337, 352, 359, 365.2, 366.3, 399.4, 399.11, 399.12, 399.13, 399.15, 399.16, 399.18, 399.21, 399.30, 454.51, 454.52, 454.55, 454.56, 701.1, 740.8, 740.12, 9505, 9620, 9621, 9622, and Article 17 (commencing with Public Utilities Code Section 400)) was signed into law, mandating a reduction in greenhouse gas emissions to 40 percent below 1990 levels by 2030 and to 80 percent below 1990 levels by 2050.

D. In 2018, Senate Bill 10 (Stat. 2018, Ch. 312, codified at Public Utilities Code sections 399.11, 399.15, 399.30, and 454.53) was signed into law, directing that the Renewables Portfolio Standard to be increased to 60 percent renewables by 2030 and establishing a policy for eligible renewable energy resources and zero-carbon resources to supply 100 percent of electricity retail sales to California end-use customers by 2045.

E. The Parties each hold various powers under California law, including, but not limited to, the power to purchase, supply, and aggregate electricity for themselves and customers within their jurisdictions in accordance with Public Utilities Code Sections 333.1 and 366.2; they are therefore properly empowered to enter into this Agreement under the Joint Exercise of Powers Act (Government Code Section 6500 *et seq.*, the “**Act**”).

G. The Parties desire to enter into this Agreement to document the Authority's repayment obligations to the City for all such funds expended on behalf of, or in support of, the formation of the Authority and implementation of the CCA program.

### AGREEMENT

**NOW THEREFORE**, in consideration of their mutual promises and obligations, the Parties hereby agree as follows:

1. City Loan to the Authority.

1.1. Formation Costs. The Authority acknowledges that the City has expended certain City funds toward Formation Costs and agrees to reimburse the City for such costs in an amount not to exceed \$250,000 dollars, subject to the repayment provisions herein.

1.2. Pre-Launch Costs. The City agrees to loan the Authority Pre-Launch Costs in the amount of \$2,500,000 by January 1, 2021, which shall be used by the Authority for working capital costs associated with the Authority's launch, anticipated in 2022.

1.3. Launch Costs. The City agrees to post the necessary cash collateral, not to exceed \$5,000,000, in order for the Authority to secure a credit facility for its Launch Costs for additional working capital associated with power procurement and operational support ("**Credit Agreement**"). The City will also provide a loan for Launch Costs if needed by the Authority should a Credit Agreement be unavailable or insufficient to cover the Authority's working capital needs. The terms and conditions of any City loan to the Authority for Launch Costs (excluding the cash collateral requirement above) shall be negotiated and agreed upon in an amendment to this Agreement, subject to the reasonable approval of the Parties. The Authority shall provide the City with the Authority's *pro forma* demonstrating the amount needed for the aforementioned City loan.

1.4. City Loan Amount. Formation Costs, Pre-Launch Costs, and Launch Costs shall be collectively referred to herein as "**City Loan Amount.**"

2. Repayment; Interest.

2.1. Repayment Date. The Authority shall repay the City Loan Amount to City, plus interest, no later than the repayment date, which shall be January 1, 2027. The Parties acknowledge that they may modify the Repayment Date for the Launch Costs in an amendment to this Agreement depending on the terms and conditions of the Credit Agreement.

2.2. Interest Rate. In accordance with subsection 2.3, interest shall be paid on all outstanding portions of the City Loan Amount that bear interest. The interest rate on any outstanding amount shall be calculated according to the sum of the following calculation of each respective quarter:
